Region Two provides transportation to all programs from each sending school. Students are required to have permission from parents or guardians to transport themselves to and from school. Students must be issued a parking permit to park on Region Two grounds.

My son/daughter, _____, has my permission to drive our personal vehicle rather than ride on the Region Two bus.

The Maine Attorney General has advised Region Two that because of heightened security, student driven vehicles are subject to search while on school grounds. I understand that the parking permit is a privilege that can be taken away for inappropriate behavior. I understand the following rules must be adhered to at all times.

1. Students will travel alone and not transport other students before or after Region Two classes.
2. Students will travel directly to and from Region Two and the sending school or home.
3. Student drivers will be required to begin and end class on the same schedule as the students at the Region Two class site.
4. Students will be safe and prudent drivers at all times.

Vehicles without a permit are subject to towing at the owner's expense. Students with a parking permit will be allowed a temporary parking permit for a substitute vehicle at the office.
