- 4. <u>Directors Report:</u>

 - v. Jacob Ouellette Law Enforcement received Bronze for CSI Team

The students did a wonderful job representing Region Two. 24 of the 27 CTE statewide participated in this year's competition.

- b. <u>FY20 Region Two Calendar</u> There have been no request for changes. Calendar will remain the same as presented January 15,2019. It was moved by Fred Grant and seconded by Sue McLaughlin to accept the FY20 Region Two Calendar, vote was unanimous.
- c. <u>Probationary Contracts</u> The following recommendation were made:

- iii. <u>Audrey Violette</u> Electrical Instructor 2nd year probationary contract. It was moved by Laura Farnsworth and seconded by Sue McLaughlin to renew Audrey Violette's contract, vote was unanimous.
- iv. <u>Josh Murchie</u> Auto Collision Instructor 2nd year probationary contract. It was moved by Ed McGillicuddy and seconded by Sue McLaughlin to renew Josh Murchie's contract, vote was unanimous.
- v. Rob Greenier Forestry Instructor continuing contract. It was moved by Stuart Kelly and seconded by Brian McQuarrie to renew Rob Greenier's contract, vote was unanimous.
- d. <u>FY20 CTE Budget</u> The state has issued their preliminary projected CTE funding for FY20. CTE's across the state received a considerable reduction in funding. Region Two's funding has been cut by \$185,000 over FY19, and \$340,000 below the states FY20 model. CTE directors across the state have contacted their local representatives to bring attention to the DOE's projected negative funding. On Monday March 11th CTE directors, State Representative, DOE Commissioner and other DOE reps met to discuss the funding. Funding is currently in review by the Legislature. A work session is expected within the next few weeks. Region Two's short-term budgeting plan was discussed as well as warrants for sending schools.
- e. <u>FY20 Adult Ed Budget</u> Joe Fagnant is finalizing the budget, which will be available at April's board meeting.
- f. Melmac Update A handout was presented showing events that have occurred since January, as well as coming events. Several staff will be attending a training session March 26-28, NTHS Induction, college tours and Bridgeyear program events will occur before end of school year.
- g. Other Cathy Bither, Culinary Arts instructor will be retiring at the end of FY19 school year. Cathy has been with Region Two for thirty-four years.
