5. Directors Report:

- a. State funding allocations updates/grants In July the DOE notified us that our original State Allocation for FY20 would be increased by approximately \$90,000. The budget committee meeting will be help in September to determine how the additional funds will be distributed. A projected Perkins Mini Grant report has been released by the DOE. Region Two is projected to receive \$73,365 for FY20. The formula was changed this year to factor the economically disadvantaged population; this generated a higher grant award than previous years. The \$40M bond being proposed by the State has been reduce significantly. CTE's are expecting approximately \$10 -\$15M from the bond, funds will be used to upgrade/replace major equipment. The bond is pending Maine Legislative budget approval.
- b. Melmac Update Region Two will be hosting their Annual College and Career Fair on November 8th. Many colleges and businesses are expressing interest in the fair. College Tours are being scheduled for student. These trips will be offered to the students through-out the school year. This is an excellent opportunity for our students.

- c. Fund Raising Approval Mr. Keaton requested permission for Region Two students to hold fund raising events during FY20 school year. It was moved by Mark Ganzel and seconded by Scott White to allow fund raising during FY20; vote was unanimous.
- d. Enrollment Region Two enrollment is currently up 30% from last school year.
- e. Other The November Cooperative Board meeting is conflicting with SACS schedule. Meeting will be moved to Wednesday November 14, 2019 @ 6:00 p.m.
