- b. Melmac (handout) March/April events Program Coordinator Rachael Upton highlighted the many Melmac related activities that occurred in March. April events include Bridge Academy students attend virtual meetings with Sen. Collins and Sen. King, Gallop Poll data collection, Mechanical Systems PERC training and the Northern Maine virtual job fair. Region Two and UMPI have signed an MOU agreement that offers ECE students to earn college credit. BIW spoke with students about their three-week pre-employment training program.
